The Feds Feed Families food drive is a voluntary effort supported by Federal employees across the country who take time outside of their workday to collect and donate food for those in need.

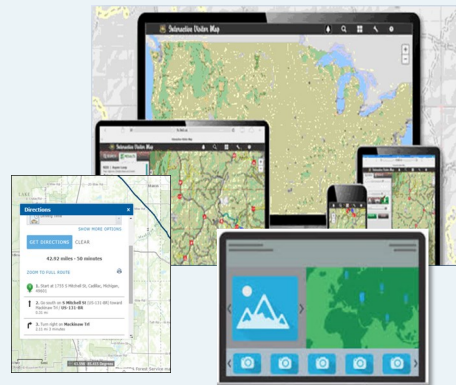
Each year, millions of Americans turn to food banks and pantries for emergency food assistance. Over the summer months, demand increases significantly, and donations decline.

Who can use it?

It was developed for all Federal Employees to use across the government. The events are scheduled for Federal Employees and will state if families and friends are welcome to join. Often there are a limited number of volunteers needed.

Accessibility

The application has been tested for 508 accessibility. Depending on the version and type of screen reader it may not be able to read the map. To remedy the challenges we have developed a PDF version of the application and exported the events in a MS Excel document. The MS Excel document will be updated as events are added or modified. Both documents may be accessed within the application.
